

RE: 48" Patuxent Raw Water Pipeline-Phase I and Phase II, Contract No. BF1582E91

Dear Customer:

Crews working for WSSC Water will be in your neighborhood soon to install pipes as part of our infrastructure renewal program. Construction to replace approximately 2.67 miles of our water main is expected to begin on or about February 15, 2021, and be complete by March of 2023, weather permitting. Final restoration of sidewalks roadways and landscaping will take place within 90 days of construction completion. Projects completed during the winter months will be restored the following spring.

Work will begin on our property adjacent to the T. Howard Duckett Dam located at 7400 Brooklyn Bridge Road. Our contractor will perform test pits within the project limits to locate underground utilities beginning on or about February 15, 2021. WSSC Water will distribute an additional letter to our customers prior to the contractor installing the 48-inch water main on Brooklyn Bridge Road and Bond Mill Road.

Please see the project map on the back to view the streets where work will be taking place. A WSSC Water inspector will supervise the work, which is being performed by Allan Myers MD, Inc.

WHAT TO EXPECT


- New water mains will be installed using an open-cut construction method, which involves constructing a trench by cutting and excavating a section of the pavement. This construction method does create noise and dust. This type of work is typically done during the day unless otherwise required as a condition of the work permit.

IMPACTS

- Anticipated Work Hours: Monday-Friday, 9:00 a.m. 3:30 p.m. Work may occasionally extend beyond these
 hours to complete specific tasks.
- WSSC Water works to minimize impacts to your water service, however, there will be occasions when your water service is disrupted. WSSC Water will provide 48-hour advanced notice prior to any planned water service interruptions.
- There also may be temporary changes to traffic patterns and/or parking restrictions. Any vehicles that have not been removed from the area (as denoted by "No Parking" signs) by the time the parking restrictions take effect will be towed to a nearby street at no cost to the owner. WSSC Water will provide 48-hour advance notice prior to any parking restrictions. Please note, during any parking restrictions, residents will still have access to your homes.
