

Lawmakers are in the midst of their own version of March Madness as they have been moving with urgency to get bills passed prior to Crossover on March 21St. Any bills passed in their originating chamber after Monday will be referred to the opposite chamber's Rules Committee prior to their introduction. So far, 2,497 bills have been introduced during the 2022 Maryland General Assembly Legislative Session.

Earlier this week, the House of Delegates passed HB 526 Washington Suburban Sanitary Commission – Plumbing and Fuel Gas Services – Licenses and Penalties (PG/MC 109-22) by a vote of 122 to 15. This bill authorizes WSSC Water, in addition to other penalties, to impose a penalty not exceeding \$5,000 for each violation to persons who violate provisions of the WSSC Plumbing and Fuel Gas Code or State law. The bill is now before the Senate for consideration and has been assigned to the Finance Committee.

WSSC Water's **Intergovernmental Relations Office (IRO)** advocates for legislation that helps WSSC Water fulfill our mission to provide safe and reliable water, life's most precious resource, and return clean water to our environment, all in an ethical, sustainable, and financially responsible manner.

Legislative Updates

Please find below the status of the three WSSC Water sponsored bills:

HB 399 Washington Suburban Sanitary Commission – Minority Business Enterprise Utilization Program – Termination Extension (PG/MC105-22), extends the statutory authority for the WSSC Minority Business Enterprise Utilization (MBE) Program for a period of one year ending on June 30, 2023. On February 24th, the bill was passed by the House of Delegates by a vote of 131-2. The bill has moved to the Senate for consideration, where it has been assigned to the Budget and Taxation Committee. The Senate bill hearing has not yet been scheduled.

HB 400 Washington Suburban Sanitary Commission – Hiring and Promotion Preferences – Veterans and Their Spouses (PG/MC 106-22), repeals the current statute pertaining to the WSSC Water competitive selection process for appointments of veterans and adopts the processes utilized by the State of Maryland. The House of Delegates voted unanimously to pass HB 400 on March 9th. The bill in now in the Senate where it has been assigned to the Finance Committee. The Senate bill hearing has not yet been scheduled.

HB 526 Washington Suburban Sanitary Commission – Plumbing and Fuel Gas Services – Licenses and Penalties, Washington Suburban Sanitary Commission – Plumbing and Fuel Gas Services – Licenses and Penalties (PG/MC 109-22), authorizes WSSC Water, in addition to other penalties, to impose a penalty not exceeding \$5,000 for each violation to persons who violate provisions of the WSSC Plumbing and Fuel Gas Code or State Law. On March 17th, the bill was passed by the House of Delegates by a vote of 122-15. The bill now moves to the Senate for consideration, where it has been assigned to the Finance Committee. The Senate bill hearing has not yet been scheduled.

2022 Watershed Season

Boating and fishing on the reservoirs resumed on March 15, 2022. Gates open ½ hour before sunrise, but if you arrive and a gate is not open, please call WSSC Water Police at 301-206-8888.

From mid-May through October, a sediment removal project is tentatively scheduled at the Triadelphia Reservoir. During that time, **all boat ramps will be closed**, **and boating will not be allowed**. In addition, the Greenbridge and Pig Tail recreational areas will also be closed. WSSC Water Commissioners' Scholarship Now Accepting Applications

WSSC Water offers annual scholarships to college students majoring in engineering fields vital to its mission. Named in honor of former Commissioners Joyce Starks and Gene W. Counihan, the scholarship program provides financial assistance to students in WSSC Water's service area who are studying engineering in order to encourage applicants/winners to consider careers in the water and water resource recovery industry – preferably, at WSSC Water.

Up to two new scholarships for \$2,000 each may be awarded: one each to a Prince George's County resident and to a Montgomery County resident. Winners are eligible for additional awards of \$2,000 each year for up to four consecutive years as long as they meet residency and grade point average (GPA) requirements. Winners also receive priority consideration for paid summer internship opportunities at WSSC Water. The application deadline is March 31, 2022.
