UPON ARRIVAL, THE CREW FOUND MANHOLE 021M OVERFLOWING APPROXIMATELY 10GPM, ONTO THE GRASSY AREA AROUND THE MANHOLE AND INTO A STORM DRAIN IN THE PAINT BRANCH BASIN. THE CREW JETTED FROM MANHOLE 020M TO 021M, A TOTAL OF 362FT, AND HIT AND RELIEVED A HEAVY ROOT AND WIPES OBSTRUCTION AT 250FT, ENDING THE EVENT.
