

A Note from WSSC Water's Intergovernmental Relations Office (IRO):

The Senators and Delegates were busy last week submitting their legislative proposals before bill introduction dates of February 6th (Senate) and February 10th (House). Any bill introduced after these dates are referred to the respective Rules Committee. To date, legislators have introduced 2,113 bills for consideration.

Governor Wes Moore recently announced that he will be submitting a supplemental budget to fully fund the Disparity Grant Program, currently short by nearly \$54 million due to outdated income tax data according to a <u>recent budget analysis by the Department of Legislative Services</u>. The Disparity Grant Program provides noncategorical State aid to low-wealth jurisdictions. It promotes equity across jurisdictions to overcome disparate tax bases – ensuring that counties, which rely on local income taxes for substantial revenue, can generate sufficient yield to fund schools, public health, public safety, roadway maintenance, and other essential community services.

WSSC Water's **Intergovernmental Relations Office (IRO)** is on the front-line advocating for legislation that impacts our work. **IRO** covers a variety of subject matters and focuses on legislation that helps WSSC Water fulfill our mission to provide safe and reliable water, life's most precious resource, and return clean water to our environment, all in an ethical, sustainable, and financially responsible manner.

Legislative Updates

WSSC Water has proposed one bill for the 2023 Legislative Session. <u>HB 783 (MC/PG 101-23)</u> - *Washington Suburban Sanitary Commission - Minority Business Enterprise Utilization Program - Revisions and Extension.* This bill updates, modernizes, streamlines, and strengthens provisions pertaining to WSSC Water's Minority Business Enterprise (MBE) Utilization Program, including extending the Office of Supplier Diversity and Inclusion's statutory authority to have an MBE program for five (5) years, ending on June 30, 2028.

The Prince George's County Bi-County Committee held a work session to discuss <u>HB 783</u> (MC/PG 101-23) on February 9th and is scheduled to vote on their recommendation for the bill during their next meeting on Thursday, February 16 at 9:00 am.

WSSC Water will continue to champion policies that provide safe and reliable water and return clean water to our environment, all in an ethical, sustainable and financially responsible manner.

Around WSSC Water

WSSC WATER MAINTAINS AAA BOND RATING ON \$360 MILLION BOND SALE

On February 3rd, <u>WSSC Water received AAA bond ratings</u> from all three financial rating agencies – Fitch Ratings, Standard & Poor's Global (S&P) and Moody's Investor Service on a February 14 sale of \$360 million in consolidated public improvement general obligation bonds. This marks 22 years in a row that WSSC Water has achieved this premier rating. The February 14 bond sale includes \$20 million in green bonds.

Proceeds from the general obligation bonds will fund key capital projects, including:

- Piscataway Bioenergy Facility: \$74.4 million
- Water reconstruction: \$71.6 million
- Contribution to Blue Plains Advanced Wastewater Treatment Plant: \$64.3 million

Proceeds from the sale of the green bonds will fund the following upgrades:

- Potomac Water Filtration Plant: \$15 million
- Large-diameter water distribution system: \$5 million
