

A Note from WSSC Water's Intergovernmental Relations Office

As the General Assembly quickly approaches the halfway mark in the 90-day legislative session, the Senators and Delegates continue to deliberate on 2,205 bills that have been introduced this Session.

Due to Governor Moore's cabinet appointments of Senator Paul Pinsky (District 22) and Senator Susan Lee (District 16), the process to fill the resulting vacancies in Prince George's County and Montgomery County Delegations are underway. In Prince George's County, Ashanti Martinez's name has been sent to the Governor to fill the vacant Delegate seat, after Delegate Alonzo Washington (District 22) ascended to the Senate. Meanwhile in Montgomery County, Delegate Ariana Kelly's name has been sent to Governor Moore to fill the vacant Senate seat in District 16. Once that vacancy has been filled, the process for selecting a Delegate will commence.

WSSC Water's **Intergovernmental Relations Office (IRO)** is on the front-line advocating for legislation that impacts our work. **IRO** covers a variety of subject matters and focuses on legislation that helps WSSC Water fulfill our mission to provide safe and reliable water, life's most precious resource, and return clean water to our environment, all in an ethical, sustainable, and financially responsible manner.

The Annapolis Observer is **IRO's** weekly update on happenings in Annapolis and highlights the progress of key bills of interest to WSSC Water, as well as provide timely updates and calendar of important dates.

Legislative Updates

WSSC Water has proposed one bill for the 2023 Legislative Session. HB 783 (MC/PG 101-23) - Washington Suburban Sanitary Commission - Minority Business Enterprise Utilization Program - Revisions and Extension. This bill updates, modernizes, streamlines, and strengthens provisions pertaining to WSSC Water's Minority Business Enterprise (MBE) Utilization Program, including extending the Office of Supplier Diversity and Inclusion's statutory authority to have an MBE program for five (5) years, ending on June 30, 2028.

The Prince George's County Bi-County Committee held a work session to discuss <u>HB 783</u> (MC/PG 101-23) on February 9th and is scheduled to vote on their recommendation for the bill during their next meeting on Thursday, February 23rd at 9:00 am.

WSSC Water will continue to champion policies that provide safe and reliable water and return clean water to our environment, all in an ethical, sustainable and financially responsible manner.

WSSC WATER EARNS PRESTIGIOUS EDUCATIONAL AWARD FROM

NATIONAL ASSOCIATION OF CLEAN WATER AGENCIES (NACWA)

The National Association of Clean Water Agencies (NACWA) presented WSSC Water with the 2023 National Environmental Achievement Award in the Public Information & Education Program at a ceremony on February 14th for its Introduction to Wastewater Treatment Virtual Unit. The prestigious award recognizes inventive water and sewer utilities' efforts to educate the public on the effects of wastewater treatment and pollution control.

WSSC Water's educational outreach program reaches an average of 2,000 students each year throughout two of the nation's largest school districts. To meet growing demand for environmental curriculum and build more online programing due to COVID-19, staff created virtual tours of the utility's Seneca and Piscataway Water Resource Recovery Facilities (WRRF), formerly known as wastewater treatment plants. Since its launch in the fall of 2021, approximately 800 students have experienced the virtual program.
