

#### A Note from WSSC Water's Intergovernmental Relations Office (IRO):

The Maryland General Assembly began its 445th Legislative Session January 11, 2023 with a greater sense of normalcy. The 47-member Senate has eight new members, and the 141-member House has 40 newcomers. Both chambers have vacancies with more expected in the coming weeks due to appointments to Governor-elect Wes Moore's administration. Wes Moore and Aruna Miller will be sworn in as the next Governor and Lieutenant Governor of Maryland on January 18, 2023. House Speaker Adrienne Jones (D-Baltimore County) and Senate President Bill Ferguson (D-Baltimore City) will both preside over their first year of a full four-year term.

Both the House and Senate have implemented a hybrid system for public testimony to allow for in-person and virtual testimony for the 2023 legislative session. Lawmakers prefiled over 250 bills before the start of the 90-day session. The General Assembly is expected to tackle issues left unaddressed from last year that include establishing a legalized recreational cannabis industry, implementing a paid family and medical leave insurance program and responding to U.S. Supreme Court decisions on abortion rights and gun control. Other topics expected to be addressed by lawmakers include renter's protections, election reform, and mental health care access.

# **Legislative Updates**

WSSC Water has proposed one bill for the 2023 Legislative Session. MC/PG 101-23 - Washington Suburban Sanitary Commission - Minority Business Enterprise Utilization Program - Revisions and Extension. This bill updates, modernizes, streamlines, and strengthens provisions pertaining to WSSC Water's Minority Business Enterprise (MBE) Utilization Program, including extending the Office of Supplier Diversity and Inclusion's statutory authority to have an MBE program for five (5) years, ending on June 30, 2028.

The Montgomery County and Prince George's County House delegations held their respective public bill hearings on December 15, 2022, and January 3, 2023. The Montgomery County Metro Washington Area Committee will hold a <u>work session</u> at 7 PM on January 16, 2023 to discuss MC/PG 101-23.

WSSC Water will continue to champion policies that provide safe and reliable water and return clean water to our environment, all in an ethical, sustainable and financially responsible manner.

#### WSSC Water Welcomes New GM/CEO Kishia L. Powell

On January 1, 2023, <u>Kishia L. Powell joined WSSC Water as the new General Manager/CEO</u> from DC Water, where she served as the Chief Operating Officer and Executive Vice President, overseeing Shared Services, IT, Engineering, Water, Wastewater, Pumping and Sewer Operations and Customer Care.

During her tenure at DC Water, Ms. Powell championed several initiatives, including a focus on operationalizing equity and environmental justice. She provided oversight for DC Water's 10-year \$6.4 billion capital improvement program, including the DC Clean Rivers program, improvements to Blue Plains, water and sewer system improvements and Lead Free DC, an initiative to replace all lead service lines in the District of Columbia. She was also responsible for leading the implementation of workstreams under the utility's strategic plan imperative for reliability. Most notably, she led the COVID-19 pandemic response and recovery efforts and introduced the campaign to recognize DC Water's frontline team as Water Heroes.

General Manager Powell has 24 years of public and private sector water and wastewater utility experience serving clients across the United States and London, England. She is recognized as a global leader in the water sector – improving service delivery, driving equity and inclusion and implementing strategies to address affordability concerns, climate change, resilience and innovation.
