CAUSE: GREASE AND WIPES EST OVERFLOW VOLUME: 452 GAL UPON ARRIVAL, THE CREW FOUND MANHOLE 069M OVERFLOWING APPROXIMATELY 2GPM, ONTO THE GRASSY AREA AROUND THE MANHOLE AND INTO A TRIBUTARY OF PISCATAWAY CREEK. THE CREW JETTED 3 MAINLINES FROM MANHOLE 070M TO 069M, 069M TO 068M, AND 068M TO 067M, A TOTAL OF 418', AND HIT AND RELIEVED GREASE AND WIPES AT 214', TO END THE EVENT.
