

Established in 1918, WSSC Water is the largest water/wastewater utility in Maryland and among the largest in the nation. Our service area spans approximately 1,000 square miles in Prince George's and Montgomery counties. We proudly serve 1.9 million residents with safe and reliable drinking water and help protect the Chesapeake Bay by treating and returning clean water back to Maryland waterways.







This Performance Report provides an overview of the performance of the MBE and SLBE programs and insights on key metrics over the last fiscal year. Our contract payments and contract awards are based on the service areas of Prince George's and Montgomery Counties, other surrounding areas in Maryland, Washington D.C. and out-of-state cities. WBE firms are included in the MBE figures throughout the report unless otherwise noted.


MBE Program Contract Payments

A key performance measure of the MBE Program is the dollar value of contract payments made to MBE firms. Actual contract payments to MBE firms measure the meaningful success of the MBE Program. During the lifecycle of a contract, several variables influence the utilization of contractors, including change orders, contract scope changes, and the availability of the proposed project team.

MBE Contract Payments by Contracting Area


Figure 3: MBE Contract Payments by Contracting Area

In FY 2023, WSSC Water's contract payments totaled over **\$530 million**, while MBE contract payments totaled over **\$148 million**, or **28%** of all contract payments, as shown in Figure 1. In FY 2023, WSSC Water exceeded **3 of the 4 Aspirational Goals**, as shown in Figure 3.

MBE Contract Payments by Classification

Figure 4 shows a breakdown of MBE contract payments by each recognized MBE classification. African American firms received the largest share of MBE contract payments, with 32% of payments, followed by Women-Owned firms at 27%. Asian American firms received 24% of MBE contract payments, Hispanic American firms received 15% and Native American firms received 2%.

Figure 4: MBE Contract Payments by Classification






MBE Contract Payments by Location

Figure 5 shows that Maryland and Washington D.C. firms received **86**% of WSSC Water's MBE payments. WSSC Water spent **37**% with MBE firms in Prince George's County and **13**% with MBE firms in Montgomery County.

MBE Contract Payments, Five-Year Comparison (FY 2019 – FY 2023)

As indicated in Figure 6, for the past five years, WSSC Water has spent an average of **29**% of its total payments with MBE firms.

Three requests for a full or partial waiver of the MBE/SLBE subcontracting goals were received in FY 2023. Of the three requests, two were approved and one was denied.

MBE Contract Awards

Contract awards are a leading indicator of future contract payments. It represents upcoming contracting needs for WSSC Water and can provide a forecast of future spending. Many contracts have multi-year terms, and the impact of contract award dollars on contract expenditures may extend beyond a single fiscal year.

WSSC Water awarded more than \$345 million in contracts, with MBE contract awards totaling more than \$101 million, or 29% of total contract awards, as shown in Figure 7. WSSC Water exceeded the Aspirational Goals for 3 out of 4 contracting areas.

MBE Prime and Subcontractor Contract Awards

Figure 8 shows the allocation of MBE Prime contracting awards and MBE subcontracting awards in each contracting area. In FY 2023, **50**% of MBE contract awards were awarded at the Prime level.

WSSC Water's SLBE Program is designed to encourage significant contract participation and promote the sustainable economic growth of small firms in Montgomery and Prince George's counties.




Figure 10: FY 2023 SLBE Contract Payments




Figure 11: FY 2023 SLBE Contract Awards

WSSC Water spent **\$31** million with WSSC Water-approved SLBE firms, with more than **\$26** million in the Construction Services contracting area.


Figure 12: FY 2023 SLBE Contract Payments

SLBE Contract Payments by Location

Figure 13 shows that 35% of SLBE payments went to firms located in Prince George's County and 31% went to Montgomery County firms. Firms are eligible for consideration in WSSC Water's SLBE Program if the firm's principal location is in Prince George's or Montgomery County, or if at least 25% of the firm's workforce resides in either county.

M/WBE Spotlight: Biosolids Hauling

Construction for our largest and most technically advanced facility, the Piscataway Bioenergy Facility, will transform how we approach recovering resources and treating biosolids. By using innovative technology to recover resources, the Bioenergy Facility will serve as the central biosolids processing site and allow the Facility to process unstabilized solids and produce green energy.

To help us transform how we process biosolids, WSSC Water commissioners recently approved a **\$27 million** Biosolids Hauling Management and Utilization contract. The contract includes hauling and transporting an estimated **75,000 tons** annually of unstabilized biosolids from WSSC Water's six water resource recovery facilities (WRRFs) to the Bioenergy Facility.

Partnerships with the vendor community are critical in helping WSSC Water achieve our clean water mission. This project is no different. We've partnered with Synagro Central as the Prime vendor for this contract, which includes **39.40**% MBE subcontracting. Nearly **21**% of the subcontracting goal will be fulfilled by Zymco Hauling LLC, a certified African American owned trucking company that specializes in hauling services, fleet management, construction and aggregate materials supply. Nearly **17**% will be satisfied by Duffield Hauling, Inc., a women-owned trucking company that also specializes in transportation and hauling services, and Recyc Systems, Inc., a women-owned agricultural company that provides alternative disposal services of biosolids, will fulfill **2**% of the MBE subcontracting goal.

Construction on the Bioenergy Facility is scheduled for completion in 2024.












OUR COMMITMENT

Our Commitment

As we prioritize Diversity, Equity, Inclusion and Environmental Justice, we remain focused on strengthening our partnerships with the diverse business community to work collectively to achieve our one-water future. We remain committed

to implementing policy and process improvements to create additional opportunities for economic growth for small, local, minority and women owned businesses in Montgomery and Prince George's counties.

On January 18, 2023, as a part of that commitment, the WSSC Water Commissioners approved and adopted the findings from the FY 2022 Disparity Study and updated MBE Regulations. The Study assessed the Commission's procurement activity with minority and women-owned business enterprises for FY 2015 through FY 2019. In addition, it analyzed the utilization and availability of firms in the marketplace, calculated any existing disparities, and collected anecdotal data from business owners, professional organizations, and WSSC Water personnel. The results from the study show an ongoing need to continue operating our Minority Business Enterprise Program to remedy the effects of discrimination.



MBE Program Improvements and Recommendations

A number of policy and programmatic improvements have been recommended to strengthen our MBE Program and increase contracting opportunities. Those include recognizing second-tier subcontracting, allowing MBE Primes to self-perform 50% of subcontracting goals, developing a race- and gender-neutral Emerging Prime Program and increasing outreach efforts.

WSSC Water is dedicated to ensuring the sustained growth and development of minority- and women-owned businesses through our contracting process and contributing to the overall economic development of Prince George's and Montgomery counties.
