- CAUSE: WIPES EST OVERFLOW VOLUME: 446 GAL UPON ARRIVAL, THE CREW FOUND MANHOLE 055M OVERFLOWING APPROXIMATELY 3GPM, GOING ONTO THE GRASSY AREA AROUND THE MANHOLE, AND INTO A NEARBY STORM DRAIN THAT OUTFALLS IN ROCK CREEK. THE CREW JETTED FROM 009U TO 055M A TOTAL OF 247', AND HIT AND RELIEVED A WIPES BLOCKAGE AT 143', TO END THE EVENT.
- IMPACTS UPON PUBLIC HEALTH AND STATE WATERS: WET WEATHER DISCOLORATION NOTICEABLE ODOR PUBLIC ACCESS
- STEPS TAKEN OR PLANNED TO REDUCE, ELIMINATE AND PREVENT RECURRENCE: THE PROBLEM WITH THIS SEWER LINE HAS BEEN REFERRED TO LINE BLOCKAGE ANALYSIS (LBA) FOR REVIEW. A FOLLOW-UP INVESTIGATION WILL BE CONDUC-TED TO DETERMINE WHAT MEASURES SHOULD BE TAKEN TO REDUCE OR ELIMINATE THE CHANCE OF THIS LINE OVERFLOWING AGAIN.
- MEASURES INITIATED/TAKEN TO MINIMIZE IMPACT: RAKED AREA LIME
