CAUSE: ROOTS EST OVERFLOW VOLUME: 60 GAL

UPON ARRIVAL, THE CREW FOUND MANHOLE 549M OVERFLOWING APPROXIMATELY 0.5GPM, ONTO THE GRASSY AREA AROUND THE MANHOLE, AND INTO A NEARBY STORM DRAIN THAT OUTFALLS INTO THE MUDDY BRANCH BASIN. THE CREW JETTED FROM MANHOLE 548M TO 549M A TOTAL OF 70', AND HIT AND RELIEVED A HEAVY ROOT BLOCKAGE AT 70', TO END THE EVENT.
