- CAUSE: DAMAGED BY OTHERS EST OVERFLOW VOLUME: 356 GAL UPON ARRIVAL, THE CREW FOUND MANHOLE 084N OVERFLOWING AT 2GPM ONTO THE HOMEOWNERS FRONT YARD. THE CREW JETTED FROM MANHOLE 050M TO MANHOLE 051U, AND HIT AND RELIEVED A HEAVY PAPER AND ASPHALT BLOCKAGE AT 230', TO END THE EVENT. THE SOURCE OF THE ASPHALT WAS FROM A RECENT NON-WSSC PAVING PROJECT ON THE STREET.
- IMPACTS UPON PUBLIC HEALTH AND STATE WATERS: DRY WEATHER NOTICEABLE ODOR PUBLIC ACCESS

STEPS TAKEN OR PLANNED TO REDUCE, ELIMINATE AND PREVENT RECURRENCE: THE PROBLEM WITH THIS SEWER LINE HAS BEEN REFERRED TO LINE BLOCKAGE ANALYSIS (LBA) FOR REVIEW. A FOLLOW-UP INVESTIGATION WILL BE CONDUC-TED TO DETERMINE WHAT MEASURES SHOULD BE TAKEN TO REDUCE OR ELIMINATE THE CHANCE OF THIS LINE OVERFLOWING AGAIN.

THE CREW SPREAD LIME IN THE GRASSY AREA AROUND THE MANHOLE.
