CAUSE: ROOTS & GREASE EST OVERFLOW VOLUME: 238 GAL UPON ARRIVAL, THE CREW FOUND MANHOLE 143M OVERFLOWING AT 1GPM INTO THE GRASSY AREA AROUND THE MANHOLE AND INTO A NEARBY STREAM THAT OUTFALLS INTO ROCK CREEK. MANHOLE 142U WAS ALSO FULL. THE CREW JETTED FROM MANHOLE 141U TO 142U A TOTAL OF 194', AND RELIEVED A HEAVY GREASE AND ROOTS BLOCKAGE AT 15', TO END THE EVENT.
