CAUSE: GREASE AND WIPES EST OVERFLOW VOLUME: 190 GAL UPON ARRIVAL, THE CREW FOUND MANHOLE 199M OVERFLOWING 1 GPM, ONTO THE GRASSY AREA AROUND THE MANHOLE, AND INTO A RETENTION POND, AS WELL AS A CREEK THAT OUTFALLS INTO WESTERN BRANCH. THE CREW JETTED FROM MANHOLE 353U TO 199M A TOTAL OF 510', AND HIT AND RELIEVED A HEAVY GREASE AND WIPES BLOCKAGE AT 390', TO END THE EVENT.

STEPS TAKEN OR PLANNED TO REDUCE, ELIMINATE AND PREVENT RECURRENCE:

LIME VISIBLE SOLIDS REMOVED

THE CREW SPREAD LIME IN THE GRASSY AREA AROUND THE MANHOLE, AND REMOVED ALL VISIBLE SOLIDS.
