CAUSE: ROOTS & GREASE EST OVERFLOW VOLUME: 963 GAL UPON ARRIVAL, THE CREW FOUND MANHOLE 003J OVERFLOWING 3 GPM, ONTO THE PAVEMENT SURROUNDING THE MANHOLE, AND INTO A NEARBY STORM DRAIN THAT ENTERS NORTHWEST BRANCH. THE CREW JETTED FROM MANHOLE 006U TO 003J A TOTAL OF 260', AND HIT AND RELIEVED GREASE AND ROOTS AT 60', TO END THE EVENT.

IMPACTS UPON PUBLIC HEALTH AND STATE WATERS: DRY WEATHER

STEPS TAKEN OR PLANNED TO REDUCE, ELIMINATE AND PREVENT RECURRENCE:

THE PROBLEM WITH THIS SEWER LINE HAS BEEN REFERRED TO LINE BLOCKAGE
ANALYSIS (LBA) FOR REVIEW. A FOLLOW-UP INVESTIGATION WILL BE CONDUCTED TO DETERMINE WHAT MEASURES SHOULD BE TAKEN TO REDUCE OR ELIMINATE
THE CHANCE OF THIS LINE OVERFLOWING AGAIN.

MEASURES INITIATED/TAKEN TO MINIMIZE IMPACT: FLUSHED BACK INTO MANHOLE

THE CREW FLUSHED SOLIDS BACK INTO THE MANHOLE, AND WASHED DOWN THE PAVEMENT WITH DECHLORINATED WATER.
