UPON ARRIVAL, THE CREW FOUND MANHOLE 124M OVERFLOWING 3 GPM, ONTO THE GRASSY AREA AROUND THE MANHOLE, AND INTO A NEARBY CREEK IN THE NORTHWEST BRANCH BASIN. THE CREW JETTED FROM MANHOLE 074M TO 075U, A TOTAL OF 190', AND RELIEVED A HEAVY GREASE OBSTRUCTION AT 190', TO END THE EVENT.
