## **Preliminary Scope**

Provide Commercial Landscaping and Restoration Services on an asneeded basis at various WSSC Water facilities and jobsites in Prince George's and Montgomery Counties.

### **Services include:**

- Area restoration
- Tree and shrub installation/maintenance
- Seeding, sodding, ground cover
- Minor grading and soil preparation
- Decorative landscaping





### **Contractor Responsibilities:**

- Remove unsuitable dirt and replace with topsoil,
- Fine grade disturbed areas,
- Plant trees, shrubs, flowers, sod, seed, mulch, or ground cover to blend with undisturbed areas
- Additional work includes tree trimming, tree removal, deer protection removal, invasive species control, reforestation, etc.

Designated areas to be restored will be marked and designated the restoration materials. Concrete or asphalt replacement is not included in the contract.





#### **Additional Services:**




