CAUSE: ROOTS & GREASE EST OVERFLOW VOLUME: 106 GAL UPON ARRIVAL, THE CREW FOUND MANHOLE 278U OVERFLOWING ONTO THE GRASSY AREA AROUND THE MANHOLE. THE CREW JETTED FROM MANHOLE 276M, THROUGH 277M, TO 278U, A TOTAL OF 222', AND RELIEVED A HEAVY GREASE AND ROOT BLOCKAGE AT 222', TO END THE EVENT.

IMPACTS UPON PUBLIC HEALTH AND STATE WATERS: DRY WEATHER NOTICEABLE ODOR PUBLIC ACCESS

STEPS TAKEN OR PLANNED TO REDUCE, ELIMINATE AND PREVENT RECURRENCE: THE PROBLEM WITH THIS SEWER LINE HAS BEEN REFERRED TO LINE BLOCKAGE ANALYSIS (LBA) FOR REVIEW. A FOLLOW-UP INVESTIGATION WILL BE CONDUC-TED TO DETERMINE WHAT MEASURES SHOULD BE TAKEN TO REDUCE OR ELIMINATE THE CHANCE OF THIS LINE OVERFLOWING AGAIN.
