CAUSE: ROOTS & GREASE EST OVERFLOW VOLUME: 240 GAL UPON ARRIVAL, THE CREW FOUND THE PROPERTY LINE CLEANOUT OVERFLOWING ONTO THE GRASSY AREA AROUND THE CLEANOUT. THE CREW JETTED FROM MANHOLE 012U TO 013M, A TOTAL OF 220' AND RELIEVED A MEDIUM ROOTS AND GREASE OBSTRUCTION AT 110', TO END THE EVENT.
