UPON ARRIVAL, THE CREW FOUND THE PROPERTY LINE CLEANOUT HOLDING, AND HAD RECENTLY OVERFLOWED ONTO THE GRASSY AREA AROUND THE CLEANOUT A TOTAL OF 10 GALLONS. THE CREW JETTED FROM MH026U TO 028M, A TOTAL OF 166', RELIEVING A MEDIUM ROOT OBSTRUCTION AT 67', AND 110FT, TO END THE EVENT.
