CAUSE: ROOTS & GREASE EST OVERFLOW VOLUME: 1,104 GAL UPON ARRIVAL, THE CREW FOUND MANHOLE 013U OVERFLOWING AT 5GPM, ONTO THE GRASSY AREA AROUND THE MANHOLE AND INTO A TRIBUTARY OF MUDDY BRANCH. THE CREW JETTED FROM MANHOLE 013U TO 002U A TOTAL OF 248', AND HIT AND RELIEVED A GREASE AND ROOTS BLOCKAGE AT 225', TO END THE EVENT.
