CAUSE: UNKNOWN EST OVERFLOW VOLUME: 210 GAL
UPON ARRIVAL, THE CREW FOUND MANHOLE 126N OVERFLOWING 1GPM, ONTO THE GRASSY AREA, AND ONTO THE PAVEMENT AROUND THE MANHOLE. THE CREW JETTED FROM MANHOLE 125U TO 126N, A TOTAL OF 230FT, AND HIT AND RELIEVED A HARD UNKNOWN BLOCKAGE AT 175FT, TO END THE EVENT.

IMPACTS UPON PUBLIC HEALTH AND STATE WATERS:

STEPS TAKEN OR PLANNED TO REDUCE, ELIMINATE AND PREVENT RECURRENCE:
