UPON ARRIVAL, THE CREW FOUND NO OVERFLOWING MANHOLE. THE CREW FOUND A BROKEN 8IN SEWER MAIN BETWEEN MANHOLE 092M AND 091M. NO WATER WAY AFFECTED. A WSSC CONTRACTOR SET UP BYPASS PUMPING OPERATIONS, TO END THE EVENT.

NOTICEABLE ODOR PUBLIC ACCESS VISIBLE SOLIDS, IN STREAM WET WEATHER

STEPS TAKEN OR PLANNED TO REDUCE, ELIMINATE AND PREVENT RECURRENCE:

THE PROBLEM WITH THIS SEWER LINE HAS BEEN REFERRED TO LINE BLOCKAGE
ANALYSIS (LBA) FOR REVIEW. A FOLLOW-UP INVESTIGATION WILL BE CONDUCTED TO DETERMINE WHAT MEASURES SHOULD BE TAKEN TO REDUCE OR ELIMINATE
THE CHANCE OF THIS LINE OVERFLOWING AGAIN.

MEASURES INITIATED/TAKEN TO MINIMIZE IMPACT:

LIME VISIBLE SOLIDS REMOVED

THE CREW SPREAD LIME IN THE GRASSY AREA ABOVE THE SEWER MAIN BREAK, AND REMOVED THE VISIBLE SOLIDS FROM THE STREAM.
