UPON ARRIVAL, THE CREW FOUND AN UNIDENTIFIED CLEANOUT OVERFLOWING 0.5 GPM, ONTO THE PAVEMENT, AND INTO A NEARBY STORM DRAIN THAT OUTFALLS INTO THE LITTLE FALLS BASIN. A WSSC CONTRACTOR REMOVED THE UNIDENTIFIED CLEANOUT, AND INSTALLED 3' OF PVC PIPE, TO END THE EVENT.

THE CHANCE OF THIS LINE OVERFLOWING AGAIN.

MEASURES INITIATED/TAKEN TO MINIMIZE IMPACT: FLUSHED BACK INTO MANHOLE

THE CREW WASHED DOWN THE PAVEMENT WITH DECHLORINATED WATER.
