- CAUSE: ROOTS AND WIPES EST OVERFLOW VOLUME: 159 GAL UPON ARRIVAL, THE CREW FOUND MANHOLE 009M OVERFLOWING AT 1GPM, ONTO THE GRASSY AREA AROUND THE MANHOLE, AND INTO A TRIBUTARY OF CABIN JOHN CREEK. THE CREW JETTED FROM MANHOLE 008M TO 009M, A TOTAL OF 274', AND HIT AND RELIEVED A HEAVY ROOTS AND WIPES BLOCKAE AT 175', TO END THE EVENT.
- IMPACTS UPON PUBLIC HEALTH AND STATE WATERS: DRY WEATHER DISCOLORATION NOTICEABLE ODOR PUBLIC ACCESS
- STEPS TAKEN OR PLANNED TO REDUCE, ELIMINATE AND PREVENT RECURRENCE: THE PROBLEM WITH THIS SEWER LINE HAS BEEN REFERRED TO LINE BLOCKAGE ANALYSIS (LBA) FOR REVIEW. A FOLLOW-UP INVESTIGATION WILL BE CONDUC-TED TO DETERMINE WHAT MEASURES SHOULD BE TAKEN TO REDUCE OR ELIMINATE THE CHANCE OF THIS LINE OVERFLOWING AGAIN.

MEASURES INITIATED/TAKEN TO MINIMIZE IMPACT: LIME

THE CREW SPREAD LIME IN THE GRASSY AREA AROUND THE MANHOLE.
