UPON ARRIVAL, THE CREW FOUND MANHOLE 053K OVERFLOWING APPROXIMATELY 0.5 GPM ONTO A GRASSY AREA AROUND THE MANHOLE. THE CREW JETTED FROM MANHOLE 054U TO 053K, AND HIT AND RELIEVED A HARD ROOT BLOCKAGE

AT 5', TO END THE EVENT.
